Adoption Terms & Responsibilities

1. I understand that I am adopting this animal as a companion and family member. The animal will reside primarily indoors and will not be used for breeding, fighting, or any illegal purpose.
2. I agree to provide appropriate food, fresh water, shelter, exercise, mental enrichment, and kind treatment at all times.
3. I agree to provide routine and emergency veterinary care as needed, including vaccinations, parasite prevention, and prompt treatment of illness or injury.
4. I will comply with all local laws and ordinances relating to animal ownership, including leash laws, licensing, and rabies vaccination requirements.
5. Cats: I understand that declawing is not permitted for any cat adopted from Hearts of Valor Rescue. I agree that I will not declaw this cat in the future.
6. Dogs: I will not allow this dog to roam freely unsupervised and will take reasonable steps to prevent escape or injury.
7. I agree that I am adopting this animal for myself and my household, and that I will not transfer ownership, sell, or give the animal away without written consent from Hearts of Valor Rescue.
8. If at any time I am unable to keep this animal, I agree to contact Hearts of Valor Rescue and return the animal to the rescue if requested. I will not surrender the animal to a shelter, rescue, or new home without approval.
9. I understand that Hearts of Valor Rescue has provided all information known about this animal's history and behavior, but cannot guarantee temperament, health, or future behavior.
10. I agree to contact Hearts of Valor Rescue promptly if serious behavioral or medical concerns arise, so we can work together on solutions whenever possible.

No Warranty / Limitation of Liability

I understand that this animal is adopted "as is" and that Hearts of Valor Rescue makes no guarantees regarding long-term health, behavior, or temperament. I accept full responsibility for the animal upon signing this contract, and I release Hearts of Valor Rescue, its volunteers, and representatives from any liability for damage or injury caused by the animal after adoption.
